

TERMS AND CONDITIONS BEPALINGS EN VOORWAARDES

- 1 I/We acknowledge that by signing this form, I/we are authorising Absa to place an order, on my/our behalf, with the indicated supplier for the equipment as indicated on the form
 - 2 I/We acknowledge that the placement of the order is subject to credit approval of the Student Loan applied for by me/us with Absa Bank
 - 3 I/We acknowledge that the purchase amount of the equipment as indicated on this form will be added to the Student Loan application amount and will be subject to the terms and conditions of the Student Loan. I/We will remain responsible for the repayment of this amount as part of the Student Loan at all times for the term of the Student Loan regardless of whether I/we are in possession of the equipment, and any other accessories for whatever reason, including but not limited to causes of such as loss, repair, theft or damage thereof.
 - 4 I/We accept that as a condition of the purchase of this equipment under the Student Loan agreement we are required to ensure that the equipment as indicated on this form is adequately insured against any loss including but not limited to theft or damage thereof.
 - 5 I/We accept that I/we will be required to read and accept the manufacturer terms and conditions relating to the equipment prior to taking delivery of the equipment and any accessories in such a manner as determined by the issuer of the warranty. It will be my/our responsibility to adhere to the terms and conditions of such a supplier agreement.
 - 6 **WARRANTY AND LIMITATION OF LIABILITY –**
 - (i) Any equipment purchased through this offer will be subject to the manufacturers warranty
 - (ii) Absa will not in any way be held liable for any defects in equipment delivered by the manufacturer
 - 7 I/We also give authorisation to Absa Bank to effect payment to the supplier amounting to any monies owed by me/us in respect of the placement of this order with the supplier.
 - 8 Once the Student Loan has been approved, and an order has been placed with the relevant supplier, the customer will be contacted by the supplier to confirm the placement of the order and the delivery time and address.
 - 9 Suppliers undertake to deliver all equipment and/or accessories within 14 working days from date of placement of an order after receipt of payment. Any dates quoted by suppliers for the delivery of the equipment are approximate only and shall not form part of the Student Loan agreement. Absa Bank shall not be liable for any delay in delivery of the equipment and/or accessories, howsoever caused.
 - 10 The equipment will be delivered to the address provided by Customer and the customer will be required to sign for receipt of the equipment and will be required to verify their identity using one of the following acceptable proofs of identity:
 - (i) A valid passport
 - (ii) A valid ID document
 - (iii) A valid Driver's Licence
